



## TERMS and CONDITIONS (User Agreement)

**Rewards Rewards Shoppers' Network "Company" and member "Cardholder" joining the Rewards Rewards program have special advantages while shopping with the merchants within the system.**

Welcome to the User Agreement for Rewards/Rewards, Inc. This agreement describes the terms on which you may access and use the Company's services. To become a registered Cardholder, you must read and accept all of the Terms and Conditions of this agreement and the Privacy Policy. If you do not agree to be bound by the Terms and Conditions, you may not use or access its services.

Rewards Rewards mission is to build Cardholder's trust and confidence in Company by promoting the use of fair information practices. These Terms and Conditions cover Rewards Rewards Program ("Program").

### TERMS:

**Membership Eligibility - Cardholder membership is not available to minors under the age of 18 or to any users suspended or removed from the system by R/R for any reason.**

**Privacy Policy -** Company value your participation in the Company's Program and respects your right to privacy. Company pledges commitment to treat your information responsibly, and created this Privacy Policy to show you that Company is working hard to protect your information generated by being a Cardholder of the Company.

- Company does not sell information about you to others
- Company protects the security and confidentiality of information about you
- Company does not disclose your personal information with merchants with whom you patronize or any third party

#### **The personal data Company collects about you:**

- Name and Address - to send your Cash Back Rewards
- Your E-mail address - to communicate the merchant's Exclusive Targeted Offers
- Phone Number - is used as a security feature and to contact you directly, if required
- The sixteen number on your Rewards Rewards cards (maximum of five) - is used to record your Cash Back Rewards
- Your birth DAY and MONTH – is used for special offers from the merchants

Your privacy is protected to the best of Company's ability not to disclose your email to third parties without your permission. The merchant's special offers are conferred to you through the Company. Merchants do not have direct contact with you unless you so desire them to do so. You have the opportunity to accept or to reject special offers coming from the merchants.

### CONDITIONS:

Cardholder's transactions are collected by the Company to better understand their buying habits; however this information is NOT directly shared with the merchants. The information collected is used to formulate the Exclusive Targeted Offers given by merchants to help both the cardholders and the merchants.

**Description of Services -** The Company is an online shopping network of individuals and merchants, joining together to provide mutually beneficial purchase transactions. For the Cardholder, it offers savings and earnings based upon purchases made with local brick-and-mortar merchants.

**Cardholder Rewards Account –** Separate account will be maintained by Company for each Cardholder's "Reward Account" (Pending Rewards, Processed Rewards and Earned Bonuses).

The Cardholder's Pending Rewards Account will be credited at the time Merchant transmits the Authorized Transaction data (Sale) to the Company. Distributions of the Processed Rewards "Cash Back" will be made on a periodic basis to Cardholder who has accumulated the minimum of \$10. The amount and frequency may be amended from time to time. The Earned Bonuses will also be distributed to the Cardholder's Reward Account providing the Cardholder has personally shopped and earned a minimum of one dollar (\$1.00) in Cash Back Rewards for every \$10 Bonus. Any Registered Cardholder who have not accessed their website for a period of six (6) months will forfeit their pending **Cash Bonuses** and will be allocated to Registered Cardholders according to Company's discretion. Distributions to Cardholder from the Bonus Fund may also be made on a discretionary basis by the Company from time to time for various promotional programs conducted by the Company.

**Confidentially and security** - Company use physical and technical safeguards to protect your information and restrict access to your information to those who need it to perform their jobs. Company complies with all data security laws. You may elect to allow the merchant to contract you directly

#### **Email Information**

If you choose to correspond with Company through email, Company may retain the content of your email messages together with our responses.

#### **Communications from our Site/Choice-Opt Out**

From time to time Company may need to send critical service updates to you. You may not opt-out of receiving these critical service updates. At any time you wish to change your preferences for receiving communications from the site, please visit the RewardsRewards website to change your preferences or by contacting Company.

#### **Notice of New Services and Changes**

Company may use information collected to notify you about important changes to Company Website about new services and special offers you may find valuable. You may notify Company of your desire not to receive these offers.

#### **How Can You Access and Correct Your Information?**

You can update your registration information online by logging on to your account.

#### **Certain Disclosures**

Company may disclose your information if required to do so by law or subpoena or if such action is necessary to (a) conform to the law or comply with legal process served on Company t; (b) protect and defend Company's rights and property, Company's site, the users of Company's site, and/or Company's Affiliated Parties; or (c) act under circumstances to protect the safety of users of Company's site, or third parties.

#### **What About Other Websites Linked to Company's Website?**
